Appendix

Discount to members when no printed Pedigree Certificate is required

Pricing Structure:

- Discount of \$2.50 per Registration for Members NOT requesting printed Pedigree Certificates. Later request for printing of Pedigree Certificate would attract existing “Re-print Fee” of \$5.50
- Would directly reduce ABRI costs associated with printing and mailing of Pedigree Certificates. Impact would be revenue neutral.
- Would suit Members who do not plan to sell or Show registered animals within their herd.
- Need to modify Online registration procedure - A comment is to be placed on the Batch Submit page mentioning no Printed certificates required. **An updated Invoice will be sent from ABRI confirming final Payment amounts, as per current system.**

NOTE:

Further education required on this process and clarification.

- If you are selling an animal – You still require a pedigree certificate as outlined in regulations.
- Showing an animal requires evidence to be submitted to the organising committee- Requires pedigree certificate.
- Any exporting of animals where a certificate is required to meet quarantine and export requirements - Requires pedigree certificate.
- You cannot use a screen print of the herd book as validation of an animal’s registration status.
- Once an animal is registered through this process if a Stud requests a Pedigree Certificate at any time following the initial ABRI processing, an additional Fee of \$5.50 as per price Schedule is linked to request.
